FEATURES

Effervescent tablets of cleaning and disinfection, of orange colour. Quick activity against a broad spectrum of microorganisms. Very economical and easy to use. Non-corrosive.

PROPERTIES

KLORKLEEN is a powerful disinfectant against bacteria, mycobacteria, viruses and fungi. Its disinfectant efficacy was tested by the following European norms: EN 1276, EN 1040, AFNOR NFT 72150, AFNOR NFT 72170, AFNOR NFT 72190, AFNOR NFT 72290 and AFNOR NFT 72301. Its properties allow that after mixed with water, stay with a roughly neutral pH.

APPLICATION

For use in floors, walls and areas of general disinfection add 1 tablet at 5 liters of warm water (we obtain a 200 ppm solution of available chlorine).

For food handling, equipment and surfaces in contact with food, add 1 tablet to 10 liters of water (we obtain a 100 ppm solution of available chlorine).

UTILIZATION

KLORKLEEN is used for disinfection in schools, hospitals, clinics, veterinary, seniors home, offices, agro-food industry, restaurants, gyms, spas, swimming pools, etc ... and in all establishments where it is necessary a rigorous infection control.
